DIRECTIONS FOR USE

Apply only as directed

Soil & Foliar Applied Crops: Vegetables, Row, Field, Permanent, Ornamentals, Hemp.

Agrinos® 5-0-0 Soil Applied Rates: 0.5 – 4.0 lbs per acre/per application. Continuous tank agitation recommended. Fully pressurize system for micro-sprinkler, solid set or drip irrigation. Inject for at least 1 hour then flush system clean for 30-60 minutes.

Agrinos® 5-0-0 Foliar Applied Rates: 0.5 – 1.0 lbs per acre/per application. Continuous tank agitation recommended.

Recommend 50 mesh or higher screens in all in-line filters for soil or foliar applications.

Applications with Liquid Fertilizers: 0.5 – 2.0 lbs per acre in liquid starters, pop-up, and side dress fertilizers. Continuous tank agitation recommended.

Transplants or Dips: 0.25 lbs per 50 gallons of water prior to transplanting in a drench. Continuous tank agitation recommended.

Professional Lawn and Turf: 1.5 – 3.0 oz per 1000 sq. ft. Apply multiple applications through growing season. Irrigate after applications.

Home & Garden: 1 – 2 tbsp per gallon of water. Soil applied at planting throughout growing season. Apply directly to soil or through fertigation. Irrigate after application.

Cleaning Sprayer Equipment: Flush all sprayer parts with clean water, including the pump, hoses and nozzles several times prior to and after each use.

PERSONAL PROTECTIVE EQUIPMENT (PPE)

PPE is recommended when handling this product. Applicators and other handlers should wear chemical-resistant gloves, safety glasses and protective work clothing.

APPLICATION in GREENHOUSES / ENCLOSED AGRICULTURAL PRODUCTION AREAS

For greenhouse (or enclosed agricultural production areas), including transplant crop seedlings, apply 1.5 to 3.0 oz. of Agrinos® 5-0-0 per 1,000 sq. feet of trays. Begin applications with first fertilization after trays have been placed in greenhouse. Agrinos® 5-0-0 can be mixed with standard fertilizer stock solution and water with one application per week until transplants go to the field. Agrinos® 5-0-0 can be mixed with B Sure® and iNvigorate® in greenhouse transplant production.
