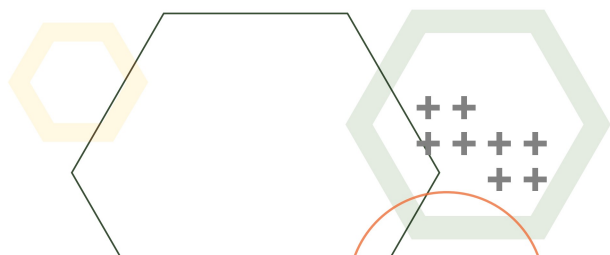

AS TISSUE SEAL

B-Lock Vine Paint will stick to fresh cuts and older tissues and will form an elastomeric coating that will stretch as the plant grows. Exposed cuts or wounds to vines can contribute to die back of canes. To avoid excessive drying out of plant tissue, coating fresh cuts and wounds can help speed the natural process of plant healing in growing conditions.

NOT FOR USE ON TREES, except for in the state of Hawaii, as a pruning wound sealant on Ohia Lehua, (*Metrosideros polymorpha*)

NOTE: Clean application equipment immediately with soap and water. Do not store this product at temperatures below 40° F or above 90° F. Do not allow to freeze.

DIRECTIONS FOR USE

Liberaly coat wound areas with B-Lock Vine Paint to create a contiguous seal coating. Scaffold or trunk applications may be made with thinner coats of product. Allow for adequate drying conditions; do not apply within 24 hours of expected rains or freezing conditions.
