### DIRECTIONS FOR USE

Mix gradually with water at 0.50 – 4.00 lbs. per gallon of water. Continuously agitate/mix tank. Spray immediately on desired crop after mixing. Do not store in liquid form. Washout spray tank after use. Application frequency based on crop nutrient needs. Store packaged product in a cool, dry place.
